WHAT WOULD YOU DO?

Because I work for Accident Scene Management and have taken the training, I realize how important the classes are -- but one cannot truly appreciate the value of that information until they are faced with an accident that happens right before their eyes! I could not have anticipated that this would happen to me.

While I was riding with my fiancée, a car passed us on our right as we were trying to make a right turn. Just a few feet in front of me I saw the person I love go flying through the air. As the car hit him, he went one direction with his bike going in the opposite direction. The first thoughts in my mind were, "Stay calm and remember what you learned in Accident Scene Management." I still have questions on if I could have done

anything different, but I think everything turned out the best that it possibly could under the circumstances. I am so grateful that I was prepared.
