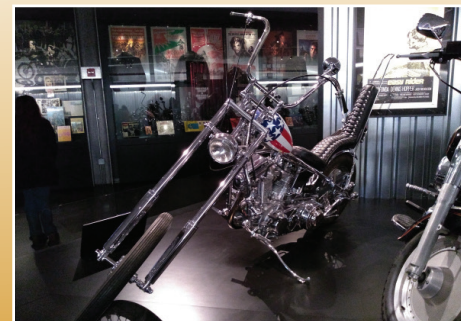
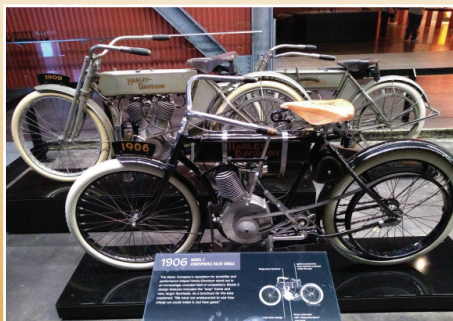

What do these things have in common? They are all themes for custom airbrushed motorcycles designed by Mike Lavallee at [KillerPaint.com](http://KillerPaint.com).

Renowned for his TRUE FIRE™ airbrush technique, Mike Lavallee traces his roots back to his first motorcycle rally in Laconia, New Hampshire. It would become a weekend event that would permanently change his life.

Sunny California was set ablaze, when Mike's signature flame jobs burst onto the scene. His collaborations with Chip Foose of Foose Design, and close friendship with Jesse James of West Coast Choppers landed Mike his first spot on television. He has appeared as a guest artist on The Discovery Channel's, "Monster Garage," as well as TLC's popular "Overhaulin'" and "RIDES".

My favorite design is an AC/DC tribute that Mike airbrushed on a Harley Davidson. One side of the gas tank features "Rock N Roll Train," while the other side showcases the cover of the "Highway to Hell" album, with the band below the burning highway sign. Additional flames tie the images from the top and sides of the tank into a single flowing piece.

Mike has poured over 30 years of his life into his artwork, making it his primary focus, second to none. It's been a journey from one end of the country to another, travelling the motorcycle circuit as an artist until choosing to settle in the Pacific Northwest. If you want to communicate easily with everyone on your next group ride, look no further than the PackTalk Bold from Cardo Systems. This state-of-the-art device is much more than a wireless intercom. It lets you stay connected with a small group, a pack of up to fifteen people, or simply another rider.

High quality, long distance communication is made possible with advanced DMC mesh technology. DMC connects a group in a web, so riders can come and go, disconnecting and reconnecting at any time, without affecting the rest of the group. This is far superior to a Bluetooth "daisy chain" that breaks apart the whole group with one lost connection.

Other features include voice-activation for hands-free operation, full GPS and phone connectivity, a killer app, smart radio, JBL audio system, and Bluetooth to pair with older helmet communicators. The device is waterproof and can be charged while you ride. Two thumbs up for a highly functional headset that really steps up the game.
