

The Highest Paved Ride in NORTH AMERICA

Colorado is hands down on of the best places to ride a motorcycle, and everyone has heard of Pikes Peak, Rocky Mountain National Park. But unbeknownst to a majority of vacationers is that the highest paved road in North America is only 45 minutes outside of Denver, a place called Mt. Evans.

After clearing the park booth your climb begins in earnest with numerous switchbacks. It isn't long before you are out of the trees and on a clear day you can see a spectacular distance, including to Pikes Peak to the south. Once you reach the parking lot at the top, a short hike to the summit nets you the best 360-degree mountain top view in North America.

At 14,265 feet Mt. Evans is 150 feet taller than Pikes, but due to the famous hill climb race of its southern neighbor it is significantly less travelled. Mt. Evans, is 90 minutes to the top, from downtown Denver. Don't forget to grab your "Highest Paved Road" souvenir at the shop near the entrance gate.

Smart Helmets Hit The Market

Head Protection & Crash Alerts With Advanced Safety Features!

I first heard about Quin helmets at a meeting of the National Academy of Motorcycle Injury Lawyers. The idea immediately made sense to me... the company has designed a helmet that alerts emergency contacts when you crash your bike and immediately pinpoints your location with advanced GPS and app features. **That's smart!**

After a bit of research, I discovered that money for the idea was raised on Kickstarter a couple years ago and the first shipments to backers started going out earlier this year. There are a lot of helmet manufacturers, but Quin and Skully are the two most innovative brands that stand out when you start discussing safety, technology, and motorcycle helmets.

Skully Helmets was the first to invent smart motorcycle helmets back in 2014. They shut down two years later amid lawsuits from nearly 2,000 Indiegogo backers who bought into the cool-sounding augmented reality helmet and were unable to ship, despite having raised \$2.5 million through the Indiegogo crowdfunding campaign, and an additional \$11 million in venture capital. Now Skully is back from the dead and under new ownership.

The difference between the two companies is dramatic. Skully relies on high tech features to support their \$1,800 cost, while

Quin is singularly focused on rider safety with a more reasonably priced \$299 to \$399 certified helmet.

Another safety benefit built into Quin helmets is the ability to reach out for help while riding, with a push button SOS beacon that sends an emergency message to fellow riders who can respond and coordinate with your position to provide support. This is a first-of-its-kind system for riders who are being harassed or need help while on-the-move, or at any time when it is not safe to stop and make a call.


