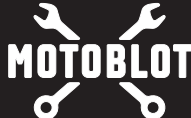


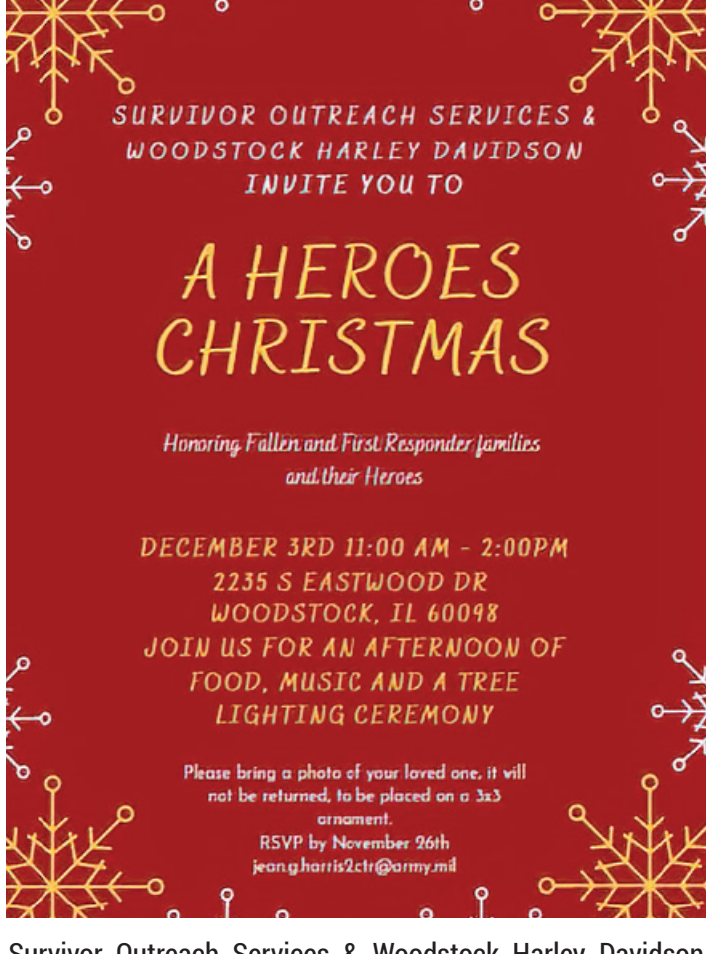

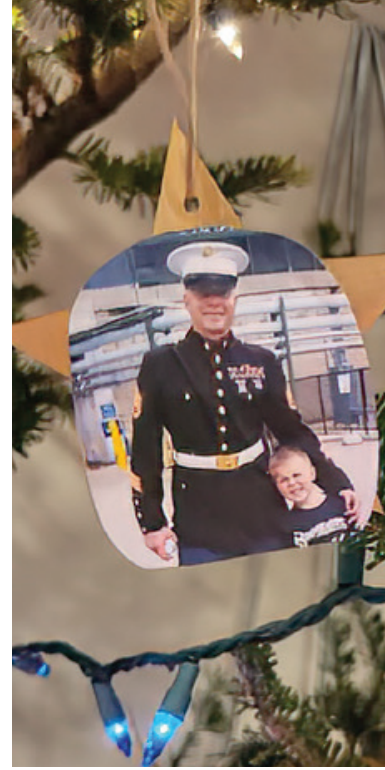

Toys For Tots 2022 - Another Year in the Books

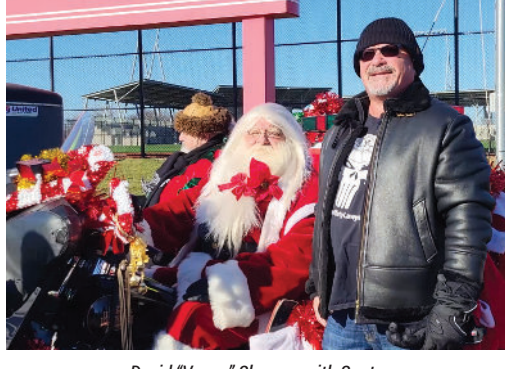
