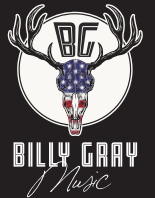
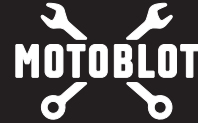

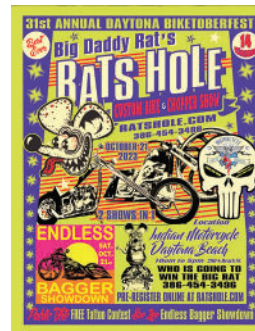

Fall Riding in the Midwest

Autumn is a special time of year. The leaves are changing, the weather is cooling off and it's a great time to enjoy the beautiful scenic roads the Midwest has to offer. But as fall approaches, so do some additional riding hazards.

Here are a few things to consider before you head out for a ride.

Leaves: The leaves are beautiful, the colors spectacular, however riding over leaves can create additional hazards. Fallen leaves can be slippery, especially on a turn so take care. They can also cover obstacles in the road, like branches, that can rupture tires. Keep an eye out for leaves and avoid them whenever possible. If you must roll over them, slow down and try not to use your brakes.

Children: Fall is back to school time and that means school buses, children walking, and slower speeds in school zones. Stay alert. Children can dart out into the street without warning. They don't think of the consequences and are not looking for you. YOU must look for them, especially around schools.

Potholes: We all try to avoid potholes when riding but it is important, especially in the Fall, when potholes may be hidden by leaves or standing water, and you can't see how big they really are. Potholes can destroy your tires and suspension. And the bigger ones can throw you off your bike and cause bodily injury. Leave yourself enough time and space to avoid them when possible.

Riding Gear: In the fall, when temperatures are cooler, it's important to have the proper motorcycle safety gear to protect yourself from the risk of hypothermia, where your body loses heat faster than it's produced. Fall temperatures can fluctuate quickly so be prepared for these changes. When it rains, remember that visibility is reduced, and reaction time is increased. Ride slower, so that you have the time necessary to react to anything that might happen.

Road Construction: Always be vigilant when it comes to Road Construction and its many hazards. Uneven pavement or grooved surfaces may cause your bike to pull to the side suddenly. Fresh paint can make for a slick surface. Cones and barrels can be tipped over and pushed into your lane. Traffic may stop suddenly, and the list goes on and on. It is important to slow down and increase your following distance, so you have enough time to respond to road hazards.

Keep these safety considerations in mind for the fall riding season. 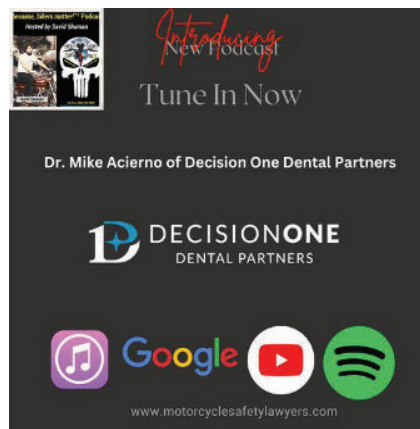
