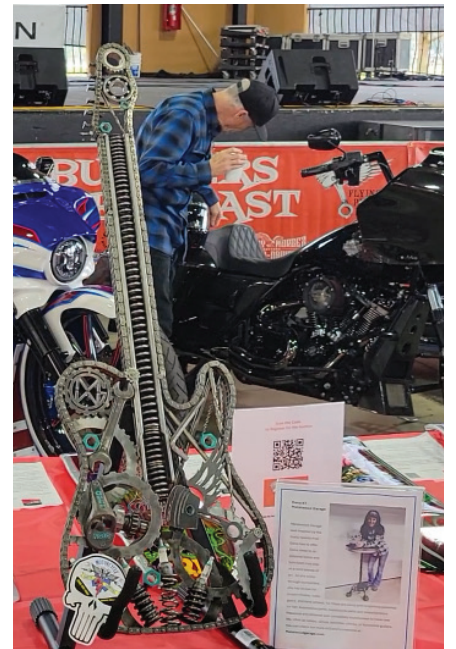

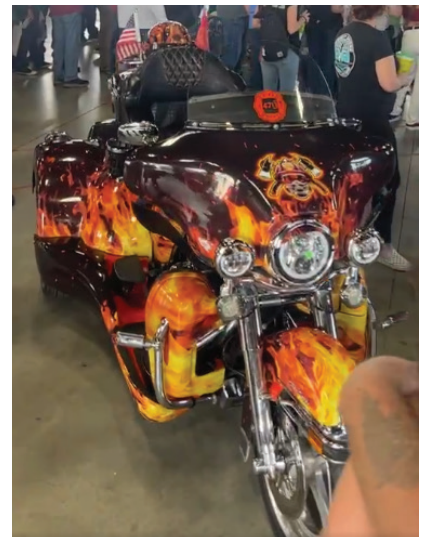

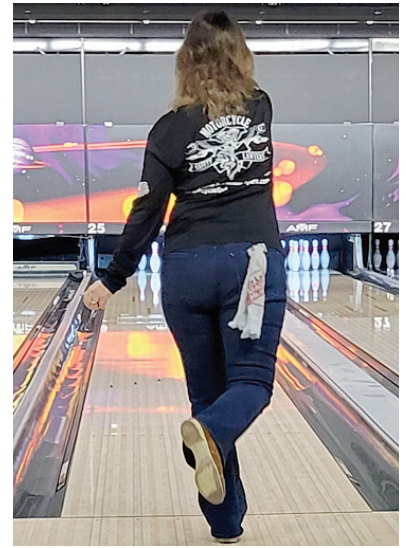

# Dana KT Handcrafts One-Of-A-Kind Pieces of Artwork at Metalwood Garage



**Metalwood Garage** was inspired by the many talents that Dana KT has to offer. Dana loves to re-purpose items and turn them into one-of-a-kind pieces of art. As she picks through dumpsters, she has an eye for broken chains, rusty gears, and bent wheels, for those are parts with enormous potential for her. Automotive parts, motorcycle parts and miscellaneous treasures are retrieved and completely transformed to have new life, often as tables, lamps, benches, clocks, or functional guitars.

**Recently, at the Flying Piston Breakfast, Dana introduced several pieces including a Metalwood Guitar. What began as an idea...was formulated into a piece of art.**

Dana and Dan came together – from two different backgrounds – to bring forth a true diamond in the rough. A fully functional guitar – made entirely of upcycled automotive parts and other metals. Dana visited Bowman Guitars where she met Dan and asked him if he would be willing to collaborate with her to create this one-of-a-kind Metalwood Guitar. After some consideration, the deal was sealed, and work began on the first playable, Metalwood Guitar.

This guitar is entirely handmade – from the fire forging in Dana’s workshop to the delicate, intricate stringing from Dan’s workbench.

You never know when inspiration will strike. Dana is always creating new and unique pieces. “I don’t really consider myself a welder, I am an artist, and my welding is the glue that holds my creations together,” says Dana.
