## New Motorcycle Laws for 2026

### Key 2026 Illinois Motorcycle Law Updates:

- **Expanded Scott's Law (Move Over Law):** Effective in 2026, this law expands to protect all stationary emergency vehicles, not just police cars. Motorcyclists must move over or slow down for any authorized vehicle, including tow trucks, stationary or in motion.
- **Motorcycle Safety Training (HB 1226/Senate Bill 2075):** New legislation (signed Aug 2025) requires IDOT to establish standardized training curricula, accredits more training courses, and sets a minimum age of 16 for enrollment to increase safety and accessibility.
- **Driver License Renewal (Road Safety & Fairness Act):** Starting July 1, 2026, the age at which drivers must take a behind-the-wheel test to renew their license is increased from 79 to 87.

Note: The [Illinois Motorcycle Operator Manual](#) requires adherence to all traffic laws, signs, and signals.

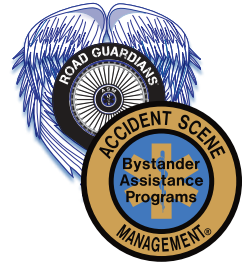
